

KEY WORDS: Kagan –is new Bukhara, most famous touristic attraction of Kagan-Emir Palace, Development Strategy of New Uzbekistan, Kagan bridge between Bukhara, State program regarding development of Kagan tourism opportunities

ABSTRACT: Kagan is a satellite town of ancient Bukhara. Here is the starting point of the railways of Uzbekistan, which appeared 12 kilometers away from the city. The city has 2 archaeological and 32 architectural monuments of the cultural heritage of Uzbekistan. The most famous is the Palace of the Emir of Bukhara, architectural monuments of the old part of the city: the building of the Russian council, the synagogue, and others. Although the Emir's Palace, with its splendor, dominates the list, other sites such as the Italian Hotel and the Russian Consulate building are a testimony to the rich and interesting history of the town, and one that needs to be shared with future tourists stopping by in Kagan. The World Bank has identified Kagan's rich "colonial city" heritage as a great potential to support tourism-related economic growth. Kagan district is an administrative unit in the Bukhara region of Uzbekistan⁴. The administrative center is the city of Kagan (not part of the district). The district has 32 archaeological (Dakhma Sheibanids, Dakhmai Shokhon, etc.), 29 architectural monuments and 2 cultural heritage sites of Uzbekistan. The most famous of them are: the mazars of Bahauddin Nagshband, Sayyid Amir Kulal and Khuja Kabul Akhbor Vali. Considering that pilgrimage tourism is a driving force in the district, work is underway to create a tourist quarter on the sites of the Mahalla "Niyoz Khodji", mahalla "Cholok" of the Kogon district. It is planned to create about 100 service, shopping complexes, hotels, craft centers. As a result of the implementation of these projects, the number of tourists reached 500 thousand (75 thousand foreign, 425 thousand domestic) in 2023. There is an opportunity to provide the district economy with income in the amount of 22 billion soums from tourists and create new jobs for 1,136 residents.

Uzbekistan-2030 Strategy targets and it was signed president decree on July 27, 2023 No. PP-238 "About measures for further acceleration of reforms and the effective organization of system of public administration in the sphere of tourism in the territory of Uzbekistan". The tourism sector plays an important role in a wide range of activities aimed at finding optimal ways to develop the economy of the Republic of Uzbekistan. Tourism is one of the largest and actively developing sectors of the economy in many countries of the world: the high rate of tourism development, the size of its income has an active impact on various sectors of the economy, which helps the country to form its own tourism industry⁵. By Cabinet Ministry of Uzbekistan it was signed on 28.09.2022 decree under № 543 "On measures to further develop the tourism sector in Bukhara region in 2022-2026 years "According to Resolution of the President of the Republic of Uzbekistan № 245 dated 08.07.2024 year "On measures to realize the economic potential of regions and effectively use vacant land plots "Kagan district was included in the list of cities and districts appendix № 3 Districts and cities where master plans are being developed to create tourist destinations with all the amenities for both domestic and foreign tourists.





Also, in cooperation with the Bukhara State University and the Islamic Academy, based on the capabilities of the localities, work is being organized to enrich the content of tourist facilities and products. To provide quality service to tourists and local tourists, about 15 restaurants have been created. In order to create favorable conditions for foreign and domestic tourists, as well as to develop pilgrimage tourism, a modern hotel "Poikent Bukhara" with 104 rooms and 220 beds has started its work in front of the temple of B. Naqshband Choloki MFU. district.
